AND WHEREAS, after enforcement of J&K Re-organization Act,2019 the J&K Pre-conception and Pre-Natal sex selection/Determination (Prohibition and Regulation) Act, 2002 has been repealed and Pre-Conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Act, 1994 has been made applicable to the Union Territory of J&K.

AND WHEREAS, the matter was taken up with the Department of Law Justice and Parliamentary Affairs regarding clarification about the continuation of these Authorities in terms of Clause 14 of the Jammu & Kashmir reorganization (Removal of Difficulties) Order, 2019 dated 30th October, 2019 issued by the Ministry of Home Affairs, Department of Jammu & Kashmir.

AND WHEREAS, the Department of Law Justice & Parliamentary Affairs vide UO dated 09.12.2020 conveyed the following advice about the continuation of these Authorities:

The department is advised that the Divisional Advisory Committee, Appropriate Authority at the District Level and District Advisory Committee constituted by the Department are saved in terms of clause 14 of the Jammu & Kashmir reorganization (Removal of Difficulties) Order, 2019.



Now, it is hereby ordered that Appropriate Authority at District Level appointed vide Government Order No. 609-HME of 2011 dated 22.11.2011 shall make the registration on line using PC & PNDT Portal.
